

Henderson County 4-H Whiz Bang Buckle Shootout



March 19, 2022 at 5H Shooting Sports in Frankston, TX. This shoot is limited to the first 100 4-H shooters for American Skeet, Trap, Whiz-Bang and Sporting Clays (200 Birds total). Registration will start at 8:00 AM, Safety at 8:30 AM and shooting will start at 9:00 AM. Adults may register for Sporting Clays only with a youth member to enter the team event.

REGISTRATION IS OPEN THROUGH MARCH 5 WITH NO LATE FEES.

Concessions and lunch available on site. **Lunch is included with registration for youth participants only.**

Award Presentation: HOA Champion and Runner Up Belt Buckles will be presented for the following classes: Junior, Intermediate, Senior I and Senior II. Top Gun (highest total score over all categories) will be awarded. To qualify for HOA the shooter must participate in all four disciplines. 1st – 5th places will be awarded in Junior, Intermediate, Senior I, Senior II and will receive a medal. **HOA WILL BE pulled from ALL DIVISIONS INCLUDING LADIES BUCKLE WINNERS.** Team Sporting Clays will be awarded 1st-3rd place and receive a trophy. Adult Sporting Clays will be awarded 1st-3rd place.

Payment: Payment by cashier's check, money order or personal check made payable to Henderson County 4-H Shotgun Sports. When paying by personal check, any returned check will result in cancellation of the entry/entries that the check was paying for. To re-enter you must pay a \$30.00 return check fee. This option will only be available if there are still open slots. We will accept Venmo @HendersonCounty-ShotgunSports or Paypal payments made to "Friends & Family" to PAYPAL.ME/HC4HSS. If you do not choose "Friends and Family" the payment will be refused.

Refund Policy: Refunds minus a \$25.00 registration fee will be made to any shooter who cancels before March 5, 2022. NO refund will be made for cancellations or no shows after March 5, 2022. All requests for refunds must be received in writing by e-mail or U.S. Mail at the address provided below. All refunds will be processed and mailed after the tournament is completed. **A positive COVID test for a shooter or household member will be refunded after March 5. Proof must be sent with request for refund.**

Tie Breakers: Any ties in the Sporting Clays event will be decided by a Station Tie Breaker. All other events will have the tie settled by a shoot off.

Parent/Coach on fields: No coaching will be allowed while the youth shooter is on the field or in the cage during events. For safety reasons, parents will not be allowed on the skeet or trap fields. Failure to adhere to this rule will result in the disqualification of the youth shooter affiliated with that adult for that event. On the Whiz Bang and Sporting Clay fields spectators, parents or coaches will maintain a respectable distance from the shooting cages to allow the referee room to officiate the match. At no time may the parent, coach or spectator interfere with the duties of the referee. Failure to respect this will result in the disqualification of the youth shooter affiliated with that spectator, parent or coach. Continued failure to adhere to these rules will result in the expulsion of the parent, coach or spectator.

Shooting Carts: Shooting carts may be used at this complex. Anyone driving recklessly in a shooting cart will be asked to park the cart until the end of the shoot. No exceptions. 5H does rent carts, **YOU MUST CALL AHEAD TO RESERVE.**

4-H Enrollment: This is a 4-H event; therefore all entrants must be members of a Texas 4-H Club for the current year.

Protest Procedure: Protests should be initiated immediately to the field referee and can only be initiated by the shooter. No protest will be accepted from parents and/or coaches.

Code of Conduct: The current 4-H Code of Conduct will be enforced both on and off the field during this event. Shooters, volunteers, family members or observers may be expelled from the event, match or grounds for failure to comply. Shoot management reserves the right to refuse future registration to any shooter who does not comply with the current 4-H Code of Conduct.

Shooting Agreement & Waiver of Liability: Please fill out and return the Shooting agreement and Waiver of Liability form and return with the registration form. Each shooter (youth and adult) will need to sign the attached waiver. **You are not registered until all forms are received and complete with payment in full.**
